ARBANDS MUST BE WORN AT ALL TIMES DURING EVENT

VENDORS: SET UP DAYS: Aug 29 – 30, 2018. TIMES: 7:00 a.m. - Dark

- Deadline to reserve current lot(s): June 1, 2018.
- Rent/Lot Fee: \$100 which includes \$25 deposit per lot.
- All lot sizes are approximate.
- Vendor lot includes: 1 parking pass which MUST be presented at check-in to receive 2, 3-day armbands.
- Deposit refundable to vendors staying until 3:00 p.m. on Sun., Sept 2. Refunds available in office until 7:00 p.m. on Sunday, Sept 2.
- All Vendors in buildings MUST depart by 8:00 p.m. on Sunday, Sept 2, 2018.
- Vehicles MUST display parking pass in the front window on the review view mirror – MUST be visible for EMS.
- NO VEHICLES DRIVING ON GROUNDS DURING EVENT HOURS OF 8:00 a.m. – 8:00 p.m.
- Each rented vendor lot must sell goods. Vacant lots are not permitted and will be forfeited.
- No sub-letting lots.
- Electricity where available costs \$25/1 outlet. Extension cords must be heavy duty 14/3 only - no household/indoor, no spliced or taped extension cords.
- Ohio DNR requires all animal parts for sale to be tagged.

GOLF CARTS:

- All golf carts and motorized handicap scooters must be registered at entrance. \$25 golf cart permit is required by insurance.
- Permit sticker must be applied to both golf carts and scooters.
- Golf cart driver must be 16 or older.
- Golf carts cannot pull anything – wagons, trailers etc.
- Golf cart motors will shut off automatically when you remove your foot from the accelerator. We reserve the right to refuse any carts.
- Selected buildings do allow golf cart access. Those buildings that do not, signs will be posted at building entrances.

CAMPING: Camp Fee \$75.00 – Includes 2, 3-day armbands and one parking pass

- Camper units must be 15' apart side to side and 10' apart end to end. All lot sizes are approximate.
- Tents must maintain 5' distance from any other unit. Tents must have retardant finish
- Each unit must have an ABC fire extinguisher. If cooking with oil you must have a K fire extinguisher.
- No discharge of grey water on ground. Use dump station located at front campgrounds at Gate A.
- Please dispose of trash in dumpsters.
- Extension cords must be heavy duty 14/3 only. No household/indoor, no spliced or taped extension cords.
- Must display parking pass with lot number- MUST be visible for EMS.
- Grills only, no fires.
- ABSOLUTELY NO SELLING in camping-only area.

FIREARMS:

- No live ammo.
- All side arms must be visible and abide by conceal carry laws.
- Guns must be secured and abide by all state and federal laws.

MISCELLANEOUS:

The following items are **NOT permitted at any time during the Event:**

bicycles, motorcycles, gators, 4-wheelers, glass bottles, no selling fireworks or pornographic items

- No selling food or drinks unless you are a food vendor.
- Pets must be registered at gate.
